Time-of-Use

Time-of-Use rate plans can help you save money based on when your business uses energy. Prices are higher during peak hours and lower at all other times.

See chart at right for peak hours and to learn more, visit **pge.com/tou**.

Business Low Use (B1) is a good choice if your small business has low energy demand of less than 75 kW.

Business Low Use Alternative (B6) is a good choice if your small business has low energy demand of less than 75 kW and has some flexibility to adjust energy use throughout the day.

Business Medium Use (B10) is a good choice if your business has moderate energy demand of consistently under 500 kW and includes a Demand Charge per kW based on maximum load.

Business Medium-High Use (B19)* is a voluntary rate plan for large and medium businesses with moderate to high energy demand consistently under 500 kW. This rate features lower energy rates but a higher Demand Charge than the B10 Rate Plan.

*Business Medium-High Use (B19) and Business High Use (B20) are mandatory for customers with energy use over 499 kW and over 999 kW, respectively.



Peak Day Pricing

Peak Day Pricing combines a Time-of-Use rate with surcharges on 9 to 15 Event Days each year, plus credits on all summer usage. On Peak Day Pricing Event Days, hours are 4–9 p.m. **pge.com/pdp**

Clean Energy Alternatives and Rates

Renewable Generation (e.g., Rooftop

Solar) is a program that enables you to install a generating system, interconnect to the PG&E grid and receive credits to offset the cost of your energy usage. With certain additional requirements, storage can also be installed to increase the value of your system.

Option R eligibility has expanded to include new rates and clean energy equipment and a new program cap has been established.

Natural Gas Rate Plans

Your rate plan is determined by the level of service you need and the amount of gas used per month. For details and more information on all gas rates, visit **pge.com/tariffs**.



Small Commercial (G-NR1) is for businesses with average monthly use less than 20,800 therms for the last 12 months in which gas use exceeded 200 therms.

Large Commercial (G-NR2) is for businesses with average monthly use greater than 20,800 therms for the last 12 months in which gas use exceeded 200 therms.

For both gas rates, you may choose who supplies your natural gas—PG&E or a third party gas supplier. We will continue to deliver gas to your business regardless of which supplier you choose. Both rates are also available to separately metered common areas in a multifamily complex.

Rates for Natural Gas Vehicles

Refueling Stations for Natural Gas Vehicles (G-NGV1)

applies to the sale of uncompressed natural gas for the sole purpose of compressing it for use as a motor vehicle fuel while **G-NGV2** provides compressed service at our stations open to the public.

G-NGV4 is for natural gas fueling stations that have elected noncore service and maintain an average monthly use greater than 20,800 therms for the last 12 months, through a single meter, excluding the months that do not exceed 200 therms.
